Compliance with Environmental Laws and Regulations

CBS is fully committed to complying with all relevant UK environmental protection laws, including but not limited to:

- The Environmental Protection Act 1990
- The Pollution Prevention and Control Act 1999
- The Waste (England and Wales) Regulations 2011
- The Packaging Waste (Data Reporting) (England) Regulations 2023
- The Environmental Permitting (England and Wales) Regulations 2016

trigger points as a small producer. We aim to minimise landfill disposal and promote the safe treatment and disposal of hazardous waste

Greenhouse Gas Emissions

We will monitor and manage greenhouse gas emissions associated with our operations. CBS will strive to reduce our carbon footprint and implement initiatives to support carbon neutrality and sustainability.

Sustainable Procurement

When selecting suppliers and sourcing construction materials and tools and equipment, CBS will consider environmental criteria. We will work with suppliers who share our commitment to environmental protection and sustainable practices, including the reduction of packaging waste.

Employee Engagement and Training

All employees will receive environmental management awareness training to understand their role in achieving our environmental objectives. CBS will encourage employees to contribute ideas and suggestions for improving environmental performance.
